Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Prospectus.

This announcement is not for release, publication, distribution, directly or indirectly, in or into the United States or any other jurisdiction where such distribution is prohibited by law. This announcement does not constitute and is not an offer to sell or a solicitation of any offer to buy securities in Hong Kong, the United States or any other jurisdiction. The Shares have not been, and will not be, registered under the U.S. Securities Act or any state securities laws of the United States and may not be offered or sold in the United States absent registration under the U.S. Securities Act or except pursuant to an applicable exemption from, or in a transaction not subject to, the registration requirements of the U.S. Securities Act. There is not and it is not currently intended for there to be any public offering of securities of the Company in the United States.

In connection with the Global Offering, BOCI Asia Limited, as stabilising manager (the “**Stabilising Manager**”) (or any person acting for it) may over-allocate or effect transactions with a view to stabilising or supporting the market price of the Shares at a level higher than that which might otherwise prevail for a limited period after the Listing Date. However, there is no obligation on the Stabilising Manager (or any person acting for it) to conduct any such stabilising action, which, if taken, will be done at the absolute discretion of the Stabilising Manager (or any person acting for it) and may be discontinued at any time. Such stabilisation action, if taken, may be effected in all jurisdictions where it is permissible to do so, in each case in compliance with all applicable laws, rules and regulatory requirements, including the Securities and Futures (Price Stabilizing) Rules, as amended, made under the SFO.

Potential investors should be aware that stabilising action cannot be taken to support the price of the Shares for longer than the stabilisation period which begins on the Listing Date and is expected to expire on the 30th day after the last day for the lodging of the applications under the Hong Kong Public Offering. After this date, no further stabilising action may be taken, and demand for the Shares, and therefore the price of the Shares, could fall.

In connection with the Global Offering, the Company has granted the Over-allotment Option to the Sole Global Coordinator, exercisable at any time from the Listing Date until Wednesday, 23 January 2019, being the 30th day after the last day for lodging applications under the Hong Kong Public Offering, pursuant to which the Company may be required to issue up to an aggregate of 46,869,000 Shares, representing not more than 15% of the number of Offer Shares initially available under the Global Offering, at the Offer Price to, among other things, cover over-allocations in the International Offering. There has been no over-allocation of Offer Shares in the International Offering. Therefore, the Over-allotment Option will not be exercised.

Potential investors of the Hong Kong Offer Shares should note that the Sole Global Coordinator (for itself and on behalf of the Hong Kong Underwriters) has the right, at its absolute discretion, to terminate the Hong Kong Underwriting Agreement with immediate effect upon giving notice in writing to the Company if any of the events set out in the section headed “Underwriting – Underwriting Arrangements and Expenses – Hong Kong Public Offering – Grounds for termination” in the Prospectus occurs at any time prior to 8:00 a.m. (Hong Kong time) on the Listing Date (which is currently expected to be on Thursday, 3 January 2019).

SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.88 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.88 per Offer Share, the net proceeds from the Global Offering to be received by the Company after deducting the underwriting commissions and the estimated expenses in relation to the Global Offering payable by the Company in relation to the Global Offering, is estimated to be approximately HK\$264.5 million. The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net Proceeds from the Global Offering” below.

Applications under the Hong Kong Public Offering

- The Offer Shares initially offered under the Hong Kong Public Offering have been slightly over-subscribed. A total of 5,498 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms, through giving **electronic application instructions** to HKSCC via CCASS and to the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 73,455,000 Hong Kong Offer Shares, representing approximately 2.35 times of the 31,248,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the over-subscription in the Hong Kong Public Offering is less than 15 times of the total number of Offer Shares initially available under the Global Offering, no reallocation procedures as disclosed in the section headed “Structure of the Global Offering – The Hong Kong Public Offering – Reallocation” in the Prospectus have been applied and no International Offer Shares have been reallocated from the International Offering to the Hong Kong Public Offering. The final number of Offer Shares under the Hong Kong Public Offering is 31,248,000 Offer Shares, representing approximately 10% of the total number of Offer Shares initially available under the Global Offering.

International Offering and the Over-allotment Option

- The Offer Shares initially offered under the International Offering have been moderately over-subscribed. The final number of Offer Shares is 281,223,000 Offer Shares, representing approximately 90% of the total number of Offer Shares under the Global Offering.

DISPATCH OF SHARE CERTIFICATES AND REFUND CHEQUES

- Share certificates issued in respect of the Offer Shares will only become valid certificates of title at 8:00 a.m. on Thursday, 3 January 2019, provided that the Global Offering has become unconditional in all respects and the right of termination described in the section entitled "Underwriting – Underwriting Arrangements and Expenses – Hong Kong Public Offering – Grounds for termination" in the Prospectus has not been exercised.

In view of the high concentration of shareholding in a small number of Shareholders, Shareholders and prospective investors should be aware that the price of the Shares could move substantially even with a small number of Shares traded, and should exercise extreme caution when dealing in the Shares.

OFFER PRICE

The Offer Price has been determined at HK\$0.88 per Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

NET PROCEEDS FROM THE GLOBAL OFFERING

Based on the Offer Price of HK\$0.88 per Share, the net proceeds from the Global Offering to be received by the Company after deducting the underwriting commissions and the estimated expenses in relation to the Global Offering payable by the Company, is estimated to be approximately HK\$264.5 million. The Company intends to use such net proceeds as follows:

- (a) approximately HK\$105.8 million (approximately 40% of our total estimated net proceeds) for the continual utilisation of the pyrolysis technology for the treatment of various types of solid waste, such as municipal solid waste, highly cohesive organic solid waste, organic waste for the recycling of waste new energy batteries and waste paper residues;
- (b) approximately HK\$52.9 million (approximately 20% of our total estimated net proceeds) for the establishment of a research and engineering centre in Guangdong province;
- (c) approximately HK\$39.7 million (approximately 15% of our total estimated net proceeds) for the further commercialisation of oil sludge thermal desorption technology, and the design, investment, construction and commissioning of oil sludge thermal desorption facilities;
- (d) approximately HK\$39.7 million (approximately 15% of our total estimated net proceeds) for the investment in and the operation of the business of cement plant parallel kiln co-treatment solutions; and
- (e) approximately HK\$26.4 million (approximately 10% of our total estimated net proceeds) for working capital and general corporate purposes.

Out of the 5,498 valid applications for a total of 73,455,000 Hong Kong Offer Shares:

- 5,498 valid applications for a total of 73,455,000 Shares were for Hong Kong Offer Shares with an aggregate subscription amount based on the maximum Offer Price of HK\$1.00 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) of HK\$5 million or less (equivalent to approximately 4.7 times of the 15,624,000 Shares initially available for allocation in pool A of the Hong Kong Public Offering); and
- no applications for Hong Kong Offer Shares with an aggregate subscription amount based on the maximum Offer Price of HK\$1.00 per Offer Share (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%) of more than HK\$5 million were received.

No applications have been rejected due to invalid applications. 2 multiple applications or suspected multiple applications have been identified and rejected. One application has been rejected due to bounced cheque. No application for more than 50% of the Hong Kong Offer Shares initially available under the Hong Kong Public Offering (that is, more than 15,624,000 Hong Kong Offer Shares) has been identified.

As the over-subscription in the Hong Kong Public Offering is less than 15 times of the total number of Offer Shares initially available under the Global Offering, no reallocation procedures as disclosed in the section headed “Structure of the Global Offering – The Hong Kong Public Offering – Reallocation” in the Prospectus have been applied and no International Offer Shares have been reallocated from the International Offering to the Hong Kong Public Offering. The final number of Offer Shares under the Hong Kong Public Offering is 31,248,000 Offer Shares, representing approximately 10% of the total number of Offer Shares initially available under the Global Offering.

The Hong Kong Offer Shares offered in the Hong Kong Public Offering were conditionally allocated on the basis set forth in the paragraph headed “Basis of Allotment under the Hong Kong Public Offering” below.

The final number of Offer Shares allocated to the Hong Kong Public Offering is 31,248,000 Offer Shares, representing approximately 10% of the total number of Offer Shares under the Global Offering (before any exercise of the Over-allotment Option).

INTERNATIONAL OFFERING

The Offer Shares initially offered under the International Offering have been slightly over-subscribed. The final number of Offer Shares offered under the International Offering is 281,223,000 Offer Shares, representing approximately 90% of the total number of Offer Shares under the Global Offering.

A total of 31 placees have been allotted one board lot of the Offer Shares and a total of 85 placees have been allotted 100 board lots or less of the Offer Shares, representing approximately 29.5% and 81.0% of the total number of placees under the International Offering, respectively. A total of 93,000 Offer Shares have been placed to the placees who have been allotted one board lot of the Offer Shares, representing approximately 0.03% of the total number of International Offer Shares. A total of 14,346,000 Offer Shares have been placed to the placees who have been allotted 100 board lots or less of the Offer Shares, representing approximately 5.10% of the total number of International Offer Shares.

The International Offering is in compliance with the Placing Guidelines. The Directors confirm that, to the best of their knowledge, information and belief having made all reasonable enquiries, no Offer Shares placed by or through the Sole Global Coordinator, the Joint Bookrunners and the Underwriters under the Global Offering have been placed with any core connected person (as defined in the Listing Rules) of the Company or to any connected clients (as set out in paragraph 5(1) of the placing guidelines for equity securities in Appendix 6 to the Listing Rules (the “**Placing Guidelines**”)), or persons as set out in paragraph 5(2) of the Placing Guidelines, whether in their own names or through nominees. The Directors confirm that (a) no placee will, individually, be placed more than 10% of the enlarged issued share capital of the Company immediately after the Global Offering; (b) there will not be any new substantial Shareholder immediately after the Global Offering; (c) the number of Shares in public hands will satisfy the minimum percentage as approved by the Stock Exchange; (d) the three largest public Shareholders do not hold more than 50% of the Shares in public hands at the time of Listing, in compliance with Rules 8.08(3) and 8.24 of the Listing Rules; and (e) there will be at least 300 Shareholders at the time of Listing, in compliance with Rule 8.08(2) of the Listing Rules.

OVER-ALLOTMENT OPTION

In connection with the Global Offering, the Company has granted the Over-allotment Option to the Sole Global Coordinator, exercisable at any time from the Listing Date until 30 days after the last day for lodging applications under the Hong Kong Public Offering, pursuant to which the Company may be required to issue up to an aggregate of 46,869,000 additional Shares, representing not more than 15% of the total number of Offer Shares initially available under the Global Offering, to among other things, cover over-allocations in the International Offering. There has been no over-allocation of Offer Shares in the International Offering. Therefore, the Over-allotment Option will not be exercised.
