PROFIT ALERT — REDUCTION IN LOSS

This announcement is made by Weigang Environmental Technology Holding Group Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review on the unaudited consolidated management accounts of the Group and information currently available to the Board, it is expected to record a profit/loss attributable to owners of the Company within the range of a profit of approximately RMB1 million to a loss of RMB2 million for the six months ended 30 June 2023, reduced as compared to a loss attributable to owners of the Company of RMB28.0 million of the corresponding period in 2022. Such reduction in loss was mainly attributable to (i) the absence of approximately RMB19.3 million impairment loss from Qingchuan pyrolysis project (青川無氧裂解項目); and (ii) the decrease in impairment loss of our trade receivables.

As the Company is still in the process of finalising the interim results of the Group for the six months ended 30 June 2023, the information contained in this announcement is only based on the preliminary assessment made by the Board with reference to the unaudited consolidated management accounts of the Group, which have not been confirmed, reviewed or audited by the Company’s auditors and may be subject to adjustment. Detailed financial information of the Group will be disclosed in the interim results announcement of the Group for the six months ended 30 June 2023 which is expected to be published by 31 August 2023 in accordance with the Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
